THESIS REQUIREMENTS FOR PARTICIPANTS

Language	The thesis must be presented in English .
The body of the thesis includes: title, abstract, keywords, text, references	 Formatting: The text should be submitted in MS Word format (doc., docx); Page orientation - portrait (sheet vertically); Margins: left, right, top and bottom - 25 mm; The text font is Times New Roman, 12 points; Line spacing - single; Red line (indent) on the left - 1,25 cm; Quantity (including reference list): not less than 1 page and not more than 3 pages (A4)
Information about the author(s)	No more than 2 works are accepted from one author or the team. All lines given below should be center alignment.
	 The first line - Title (title of the thesis) is written with a capital letter. Next line - name of the author, names of co-authors. The speaker's name is underlined with a slash. Next line - Shorthand for the name of the university/organization. The name of the university/organization as it is written in the official documents. Next line - Academic degree, position, Surname and initials of the supervisor. If there are two or more authors: the organization is indicated for each co-author separately. If all co-authors are from the same organization, its name is given after the name of the last co-author.
Abstract	 The abstract should contain 4-6 sentences, or no more than 100 words. It should be indicated that it is an abstract (ABSTRACT). The abstract should not be italicized, underlined, etc. The text should not be divided into paragraphs. NO citation or reference to other works is allowed in the abstract. Abbreviations should be explained. The abstract should contain: A description of the main purpose of the study; A short description of the methodology;





	- Synthesis of the most important research results and their practical relevance.
Keywords	There should be 3-10 keywords presented right after the abstract, which may consist of separate words and phrases. It should be indicated that these are keywords (KEYWORDS). Keywords should not contain formulas, diagrams or figures.
Requirements for the thesis structure	The thesis statement should be presented after the keywords.
	 The text has to be divided into subchapters: Introduction; Relevance; Methods and methodologies, equipment, technologies that are used; Conclusion (necessarily suppose the possible prospects for further research on the topic; comparison the research with foreign and domestic counterparts); Acknowledgements (provide the reference to the financial support for the researches, gratitude to individuals and organizations); List of references The presence of double or triple spaces is not allowed. When abbreviations are used for the first time, it is required to indicate their explanations. The text of the thesis should NOT contain the titles of subchapters (Introduction, Relevance, etc.).
List of references	The List of references should contain at least 3 sources. It should be indicated that it is a list of references
	(LIST OF REFERENCES). The name of the source (name of the journal, monograph, collection of articles, conference proceedings, etc.) should be italicized and all authors should be indicated. Bibliographical references should be presented in English according to the APA standard.
Requirements for tables, figures and formulas	The text may contain tables. Captions for tables should be given above it with aligned on the left side, in the format: Table 1 Name of the table. Text formatting in tables: single spacing, font Times New Roman 12 points.





There should be no more than 2 tables in the text. It is necessary to give in the text a reference to a figure, a table, a scheme with the number of figures, table and scheme. Note: Avoid abbreviation of the names of tables, figures and equations in the caption/text. Do not write "in the table upper in the text/below in the text" or "in the figure on page 2" (because the position and page number of the table or figure may change during typesetting). All components of formulas should be designed in "Microsoft equation". The font size in formulas is 14 points. Graphical figures should be of high resolution, not less than 300dpi. If captions are used, the text must be clearly displayed. The name of the figure, scheme should be aligned in the center under the figure in the following format: Figure 1 - Name of Figure (No more than 2 figures); Scheme 1 - Name of Scheme (No more than 1 scheme).
